## NOTIFICATION FOR VTCs FOR SUBMISSION OF UC OF RECURRING FUND

With reference to above, it has been observed and reviewed by Directorate that 1354 nos of VTCs has not submitted UC of Recurring Grant sanctioned in F.yr. 2018-2019 (from 01.04.18 to 31.03.19) or earlier F,Yr. 2017-18 for few VTCs as per schedule up to 12.06.2019 to the respective Nodal Polytechnic.

This is the report collated by Directorate from different Nodal Polytechnic and Regional Offices as on 14.08.2019. The list of said 1354 nos VTCs are enclosed as Annexure-A.

This is a routine job to be done every year by VTCs and different tiers of Directorate. If this skeleton Directorate would be busy for such type of routine work, then how development activity for VE&T programme would be initiated by this Directorate.

In this context, this is to mention that the popup from during monthly requisition of remuneration of VTC Teachers/Instructors for August, 19 for the Recurring fund requirement from July, 19 to September, 19 has been duly submitted by head of the VTCs. But, without UC of earlier year how the said fund will be released. In addition, Recurring Grant module would be implemented shortly in iOSMS portal for which also the said UC data base to be uploaded first by Directorate.

In view of the above, the Directorate has decided a final date line i.e. 03.09.2019 to submit UC to this Directorate by post in the following address:

Again, it is reiterated that the Head of said VTCs are requested to follow Notification No. 066-VET/2019-20 date 02.05.19 with Annexure-I also for submission of correct UC.
