The undersigned is directed by the order of the Governor to say that the Governor is pleased to accord approval of second assignment of Part-time Teachers/Instructors having single assignment at present for Entrepreneurship Development subject (5th phase), Environmental Studies subject (5th phase), Fitter subject in Workshop Practice (4th phase), FMTD subject (2nd phase), Physics subject (5th phase), Welder subject in Workshop Practice (4th phase), Carpentry subject in Workshop Practice (3rd phase), Mathematics subject (6th phase), Bengali subject (7th phase), English subject (7th phase), Computer Application Subject (1st Phase) and Biology Subject (3rd Phase) under HS (Vocational Education) Programme, as per Annexure – A to Annexure – L respectively.

The Head of the second VTC at column no 6 of Annexure - A to L may allow engagement of said Parttime Teachers as mentioned above on receipt of 'NOC' from the first VTC initially for a period of six months to ensure quality teaching of students and will intimate the respective Nodal Polytechnic for necessary action in iOSMS portal. Subsequent renewal of engagement for the second assignment by the second VTC will depend on satisfactory performance of the concerned Part-time teacher. He/she will be entitled to get the honorarium as per prevailing rate.

The validity of offer for 2nd Assignment would be effective up to November, 2019 only.

The Governor is also pleased to cancel the name of Teachers / Instructors in earlier G.O.s including corrigendum for one VTC name as per Annexure - M & N respectively.
