Subsequent renewal of engagement for the second assignment by the second VTC will depend on satisfactory performance of the concerned Part-time Teacher/ Instructor. He/she will be entitled to get the honorarium as per prevailing rate.

The validity of offer for 2nd Assignment would be effective up to December,2019 only for HS Vocational Courses and January,2020 only for VIII+ Level Courses.
