This is to mention that the period of grant as mentioned "April to June, 2020" in the above Annexures A to J consists of Administrative Honorarium for May & June 2020, Online Teaching cost (as Training Material Cost) & Office Expenses from April to June 2020. Regarding online teaching cost, this is to inform Head of the VTCs to reimburse Mobile Data Charge @Rs. 100/- per head per month (as per our Memo No. 026-VET dated 22.04.2020 already notified earlier) for those Teachers/Instructors who have been conducting online classes subject to proof received by Head of the VTCs.

Head of those VTCs for which long pending arrear grant has been released (based on the pending UC cleared in current Fin. Year) are to note that no expenditure would be allowed for previous "Training material cost" up to March, 2019 and it is to be strictly complied by VTC Authority (Please see the period of the grant column in Annexure -A to J).
