SERIOUS CAUTION NOTICE FOR UC PENDING VTCs

This Directorate is reviewing about bad performing VTCs in terms of different parameters out of which fund management is an important key parameter to identify the quality of VTC.

At present, about 650 VTCs are lying in this category, the HOI of those VTCs are not performing well in terms of fund management i.e. submissions of UCs, requisition of grant etc. They are very much reluctant about correct Utilization of Govt. Fund. Out of 650 VTCs, 430+ VTCs are not submitting UC through online though eligible till today up to 12:30 pm in 2nd Phase in spite of repeated reminders and phone calls from Regional Offices and about 220+ VTCs have not submitted long pending manual UC till date including about 60 VTCs have not submitted the correct UC of non-recurring fund for procurement of furniture, equipment etc. in the F.Y. 2017-2018 & 2018-2019.

This Directorate is closely looking into the above issue. It has been decided by this Directorate that the VTCs not abiding Govt. Directives must be kept in abeyance after November, 2020.


It is very unfortunate to say that we requested all 430+ VTCs to submit UC through online on 15th September, 2020 or within 16th September, 2020 but the HOI of 220+ VTCs are silent, out of which maximum are for Nadia, Howrah & Hooghly District. It is requested to HOIs to follow Govt. Notifications and not to act with so autonomy.

In view of the above, this Directorate again requests HOI of the 220+ VTCs as mentioned above to do their work in connection with submission of UC with in 19.09.2020, not to wait for last date i.e. 22.09.2020.

Similarly, about 1100+ including 430+ VTCs have to submit requisition of grant through online for the period July, 2020 to September, 2020 from 25.09.2020. All of them are requested to submit through online within 25.09.2020/26.09.2020 and not to wait for last date i.e. 29.09.2020.

HOI of 220+ VTCs are reminded to submit their pending manual UC for the F.Y. 2018-2019 or earlier including correct non-recurring UC, if pending, **within 30.09.2020** positively by mail id **wbdvet@gmail.com** so that the above all VTCs may be exempted from the bad performer category.

Concerned VTC Teachers/Instructors are also requested to cooperate for the above procedure for the interest of VE&T Programme.


