NOTICE FOR CLARIFICATION OF MONTHLY REQUISITION OF REMUNERATION FOR VTC PART-TIME TEACHERS IN X+2 LEVEL AT ENHANCED CONSOLIDATED RATE

The TET&SD Department has awarded Part-time Teachers/Instructors of VTCs to work in 2(two) VTCs and accordingly about 2800+ VTC Teachers/Instructors have been assigned to work in 2nd VTC as well since the Financial Year 2017-18.

After thorough review, it has been decided that HoIs of 1st & 2nd VTC for Part-time Teachers have to disburse monthly remuneration equally in favor of those Part-timers during requisition of every month if the no. of classes inclusive of two VTCs is >=400.

However, at present there is provision only to submit requisition at consolidated rate from 1st VTC only which would be changed from the next month.

In view of the above, concerned HoIs of Grantee VTCs are requested to do the needful accordingly.
