Whereas, the Educational Institutes were closed early and has since not opened due to prevailing Covid situation, and

Whereas the Council could not hold the Theory exams for the Higher Secondary (Vocational) 2021, so in view of ensuring unhindered academic activity and in the interest of the students, the Council intends to modify the existing examination procedure.

Therefore, in exercise of the powers under sub-rule-5(i) of Rule-12 of WBSCT&VE&SD (Transaction of Business and Finance, Accounts and Audit) rules, 2019, the Council prescribes the following procedures for the time being and hereby inform all the concerned Head of the Vocational Training Centres(VTCs) that:

- The assessment of the candidates enrolled for Higher Secondary(Voc.) Examination, 2021 is being done as per methodology decided and adopted by the WBSCTVESD in accordance with there commendations of Expert Committee constituted by the competent authority of the WBSCTVESD.
- 2. However, if the situation deem to be conducive in the near future, as onetime measure, WBSCTVESD will give an option to the willing candidates to appear for Higher Secondary (Voc.) Examination, 2021 at a later date as per specified rules to be notified whereby them marks so obtained in subjects by the candidate in that written examinations shall be considered as their final marks.
- 3. To this extent all the concerned Head of the Vocational Training Centres (VTCs) are hereby instructed to submit the Formative Theory Assessment Marks for both Class XI (Batch of 2020& before) and Class XII (batch of 2021) i.e. ofthose students due to appear for Higher Secondary(Vocational) 2021 as per notifications No.SCTVSD-14014/2/2620-AO(WBSCTVESD)/2021-22/72 & 73 dated 29.06.2021& 30.06.2021 within 10.07.2021 & 13.07.2021 positively in the web application portal hosted at https://www.wbscvetpps.org.in/register
